ASSAM ACT No. 1 OF 1986

(Received the assent of the Governor on 22nd January, 1986)

THE ASSAM APPROPRIATION (No.I) ACT, 1986

Act

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State of Assam for the services of the financial year, 1985-86.

Be it enacted by the Assam Legislative Assembly in the Thirty-seventh Year of the Republic of India as follows:-

Short title.

1. This Act may be called the Assam Appropriation (No. I) Act, 1986.

Withdrawal of

Withdrawal of Rs. 41,45,98,400
State of Assam there may be paid and applied sums not from and out of exceeding those specified in column (3) of the Schedule Fund of the State amounting in the aggregate to the sum of forty-one of Assam for the crores, forty-five lakhs, ninety-eight thousand and four financial year hundred rupees towards defraying the several charges which 1985-86. 2. From and out of the Consolidated Fund of the will come in course of payment during the financial year, 1985-86 in respect of the services specified in column (2) of the Schedule.

Appropriation.

3. The sums authorised to be withdrawn from and out of the Consolidated Fund of the State of Assam by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
