THE ASSAM LAND REVENUE RE-ASSESSMENT  
(AMENDMENT) ACT, 1984

further to amend the Assam Land  
Revenue Re-assessment Act, 1936.

Preamble. Whereas it is expedient further to amend  
the Assam Land Revenue Re-assessment  
Act, 1936 hereinafter called the  
Principal Act, in the manner hereinafter  
appearing ; Assam Act  
VIII of 1936.

It is hereby enacted in the Thirty-  
fifth Year of the Republic of India as  
follows :-

Short title,  
extent and  
commence-  
ment.

1.(1) This Act may be called the  
Assam Land Revenue Re-assessment  
(Amendment) Act, 1984.

(2) It shall have the like extent as  
the Principal Act.

(3) It shall come into force at once  
but in respect of land included within  
the limits of the city of Gauhati con-  
stituted under the Gauhati Municipal  
Corporation Act, 1969 it shall be deemed  
to have come into force with effect from  
the fifth day of March, 1973. Assam Act 1

2. In the Principal Act, in section  
2, existing Clause (XI) shall be sub-  
stituted by the following, namely :—

(XI) 'Town land' means -

(a) any land included within the  
limits of any city constituted  
under the provisions of any law  
for the time being in force,

- (b) any land included within a Municipality or notified area defined in the Assam Municipal Act, 1956, <sup>Assam Act XV of 1957.</sup>
- (c) any other land which the State Government may declare as town land (under the Assam Land and Revenue Regulations, 1886 or) <sup>Regulation-I of 1886.</sup> in accordance with the provisions of section 3 of this Act.
